AND WHEREAS Muskoka Algonquin Healthcare is considering single-siting all surgical procedures at one of the hospital sites in order to balance their budget;

AND WHEREAS such a move would have a devastating impact on the Huntsville Hospital site and surrounding communities, in terms of both healthcare and economy;

THEREFORE, BE IT RESOLVED THAT the Council of the Township of Armour hereby requests that Muskoka Algonquin Healthcare removes consideration of single-siting surgery from their deliberations immediately. Carried
