

MUNICIPAL CORPORATION OF THE TOWNSHIP OF ARMOUR

BY-LAW # 18-2010

Being a By-law to Provide for Fees Charged by the Corporation

WHEREAS The Municipal Act, R.S.O. 2001, Chapter M.25, Sections 391, 394, and 400 give authority for a municipality to impose fees and charges;

AND WHEREAS the Corporation of the Township of Armour charges various fees for licenses, permits and services offered by the Corporation;

AND WHEREAS the Council of the Township of Armour deems it desirable to create a comprehensive by-law to provide for the charging of fees,

NOW THEREFORE the Council of the township of Armour enacts as follows:

That the fees set out in Schedule "A" attached to and forming part of this by-law shall be charged for licences, permits, services and documents listed therein;

That if the provisions of this by-law conflict with any other by-law of the Corporation heretofore passed then the provision of this by-law shall prevail;

That this by-law shall come into force on the final passing hereof.
