

The Municipal Corporation of the Township of Armour

By-Law #14-2017

Being a by-law to authorize the appointment of a Weed Inspector, Livestock Valuator and Fence Viewer.

WHEREAS Section 8(1) of the *Municipal Act*, S.O. 2001, c. 25, as amended, shall be interpreted broadly so as to confer broad authority on municipalities to enable municipalities to govern their affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues;

AND WHEREAS Section 8(1) of the *Weed Control Act* may by by-law appoint one or more persons as municipal weed inspectors in the area within the council's jurisdiction and fix their remuneration;

AND WHEREAS Section 4 of the *Protection of Livestock and Poultry from Dogs Act* requires that the council of every local municipality shall appoint one or more persons as valuers of livestock and poultry;

AND WHEREAS Section 2 of the *Line Fences Act* requires that the council of every local municipality shall by by-law appoint such number of fence-viewers and the by-law shall fix the remuneration to be paid to the fence-viewers and the remuneration may be fixed on an hourly or daily rate.

NOW THEREFORE the Council of the Corporation of the Township of Armour hereby enacts as follows:

1. That the positions of Weed Inspector, Livestock Valuer and Fence Viewer shall be confirmed as listed in Schedule "A" attached hereto.
2. That appointments to the positions of Weed Inspector, Livestock Valuer and Fence Viewer shall remain in place until the member provides the Township with notice of resignation or withdrawal, or until the next term of Council, whichever comes first.
3. That, should changes to appointments as listed in Schedule "A" be necessary due to vacancies created for various reasons, Council shall have the authority to make appointment or to fill a vacancy by Resolution, and that said Resolution shall be in effect only until a new By-law is enacted at the beginning of each new term of Council.
4. That an annual increase to the remuneration as set out in Schedule "A" shall be adjusted annually according to CPI which is the Consumer Price Core Index (not seasonally adjusted), as published by Statistics Canada each year, for the period covering September of the previous year to September of the current year (Section 25).
5. That By-law #4-2015 be rescinded and that this by-law shall come into force and effect on the date of passing.
