New By-laws

Please familiarize yourself with some of the new by-laws that were implemented in 2017. We have a new trailer by-law to regulate the use of trailers, a new shipping containers by-law to regulate the use of shipping containers, a new public nuisance by-law and a new parks by-law to regulate public parks and beaches. Landfill

You are required to present your landfill card upon arrival. Clear garbage bags must be used. Recycling Council of Ontario has proclaimed the week of October 16-22, 2017 as Waste Reduction Week. For additional information on hours of operation, diversion programs, HAZMAT, passes, reuse and tipping fees, please visit the Township of Armour's website and look for Landfill under the Departments tab. By-law #13-2016 was passed on April 12, 2016 and regulates the disposal of refuse and debris. Fines are set out in the By-law's Schedule A.

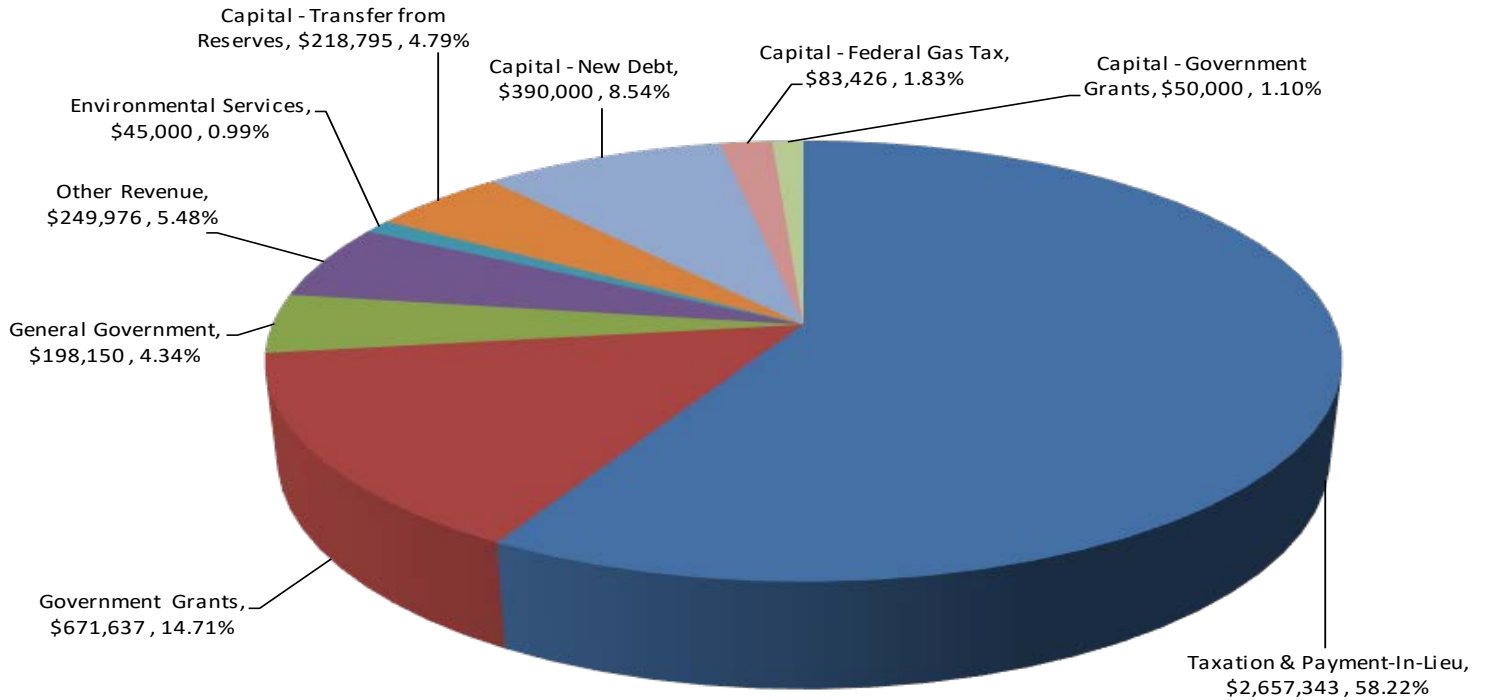

Finance

Final tax bills for 2017 are due in two installments, the first half is due on September 29th and the second half is due on October 27th. A fee of \$41.00 will be charged for any cheque returned from a financial institution. We offer a preauthorized payment plan with several options. Credit card payments are accepted through Plastiq and can be accessed through our website, fees apply. Arrears of taxes accrue interest at a rate of 1.25% per month.
